The building now houses 60+ on-site Tenants and their 150+ employees, a network of 100+ Member organizations based in Colorado, hundreds of interns and volunteers, a weekly farmers' market, a global classroom, exhibition and meeting space, and more. Posner Center Tenants and Members address development challenges in a variety of sectors, including agriculture, education, energy, health, governance, microfinance, water and sanitation, and human trafficking, among others.
