Physical and virtual collaborative workspace:

The Posner Center brings together close to 200 Colorado-based global development organizations, working in over 100 countries, and encompassing all sectors and approaches to development work. The Organization operates a 25,000 square foot collaborative workspace in Denver, called the Horse Barn, and offer expansive programming, organizational and professional development, and other educational opportunities for our community.

Development organizations face many similar challenges in their work to create change around the world. They also face similar challenges when it comes to office space. Small budgets, competition for limited resources, a lack of connection, and feeling isolated from international teams are among some of the biggest challenges for development professionals, especially in Colorado. Posner Center was created with the belief that sharing and collaboration can address these challenges and transform the way development work is done. The Posner Center Horse Barn building serves as a collaborative workspace for approximately 60 organizations that helped create efficiencies and collaboration right from the start. Tenants share space, each occupying their own footprint in the building and sharing meeting rooms of all sizes, and access to other office necessities.

While the Horse Barn collaborative workspace provides a physical home for the Colorado global development community, the Posner Center is much bigger than the building. The Organization brings together a greater virtual

community of global development professionals in Colorado, including nonprofit organizations both large and small, private enterprises, university departments, consultants, service providers, and other individuals who are concerned about international issues. Both the Horse Barn tenants of Posner Center's larger virtual community have access to the building and our programming to support their work.

Organizational and professional development:

The Posner Center leads high-quality programs that strengthen our community to amplify their impact around the globe. The Organization's programming and grant-making emphasize the creation of community, strategic connections, learning and sharing across the community, and adoption of evidence-based best practice.

The imperative to meet the United Nation's Sustainable Development Goals means that the global development community needs to be leading high-impact, transformative work around the world. Posner Center's investment in organizational and professional development is a key element of our effort to strengthen the development practice of the entire Posner Center community. The Organization partners with experts in their respective fields to co-create deeper opportunities that are identified and selected based on their ability to create meaningful change within organizations and with the communities in which they work.

Following are a just a few examples of the organizational and professional development programming provided to support the Posner Center community.

praxis. Begun in early 2018, praxis is a collaboration between the Posner Center and Regis University's Development Practice that delivers a series of monitoring and evaluation short courses so social impact professionals can strengthen their evidence-based development impact. The Organization has continued to expand these field-expert-taught course offerings to include Qualitative Data Collection, Qualitative Data Assessment, Data Visualization and Program Design, and are now offering a new praxis Certificate.

Resilience Training Series. Resilience is "the ability of people, households, communities, countries and systems to mitigate, adapt to and recover from shocks and stresses in a manner that reduces chronic vulnerability and facilitates inclusive growth." (USAID) To focus on this critical element of effective global development, the Posner Center leverages the skills and experience of our community and outside experts to lead a multi-session series on resilience in global development.

Leading Sustainable Change. The Posner Center has partnered with Alexander & Associates LLC to deliver a training series based on the Adaptive Leadership model, a framework that helps individuals and organizations adapt and thrive in challenging environments. This series focused on gaining a deeper knowledge of style and personality of self and others in order to have a deeper understanding of individual and group behaviors, and learning from failure through individual case studies and group consultations, all with the goal of affecting sustainable change within organizations.

Mentoring & Coaching. The Posner Center Mentoring Program cultivates the professional development of the Posner Center Community by facilitating a mentoring process among global development professionals as well as those working in related sectors. Our mentoring relationships are "give and give", intended to both enhance the professional development of the Mentee, and provide opportunities for Mentors to enrich their contributions to global development and further develop as leaders. Posner Center is also providing intermittent coaching opportunities to our Community. In 2018-2019 the Organization partnered with the International Coach Federation - Colorado who provided generous pro bono coaching.

Communities of Practice. To collaboratively strengthen the global development leadership skills and competencies of its community members, the Posner Center facilitates outcome-oriented professional development Communities of Practice. These communities are established and led by Posner Tenants and Members based on their current needs and interests. Current Communities of Practice include Organizational Leadership, Monitoring & Evaluation, Communications, and Gender Advocacy. Each Community of Practice meets on its own schedule and drives its own agenda, activities and programming.

The International Collaboration Fund (ICF):

ICF is a grant program that is transforming how global development work is done. The Posner Center funds innovative partnerships within our community, leveraging the power of collaboration for greatest impact. Funded projects strengthen evidence-based best practice in global development, deepen our

understanding of collaborative processes, strengthen programs and organizations, and create change in communities worldwide. The learning and value from projects can be applied by other organizations in our community or across our sector. By 2019 Posner Center has funded 34 projects, granted \$365,000 to 69 Tenant, Member and partner organizations participated for work in 19 countries.

One example of the innovative work the Organization has supported is a project between Posner Center Founding Tenant, iDE, and blockchain technology company, Bext360, that is helping small Honduran coffee farmers move up the coffee value chain via blockchain" by directly linking farmers in Honduras to coffee roasters in the United States. Through this project, iDE and Bext360 are working to improve supply chain transparency through blockchain technology to address market failures. Their partnership serves as a model for connecting coffee producers and buyers with financial and agricultural technology solutions and the project is a continued evolution of market-based approaches to poverty reduction.

For the second annual Symposium in February 2020, the Organizations convened an even larger community of leaders and agitators who are thinking differently about how we make significantly bigger impacts in global development work through collaboration. With attendees from Seattle, California, Washington D.C. and Mexico mixed with Posner Center and Colorado communities, there were two days of collective energy, insightful dialogues and lots of "big and bad" ideas in collaborative global development. The 2020 Symposium had 220 participants, 24 speakers, workshops on social entrepreneurship and monitoring and evaluation, and plenary and break-out sessions around global development themes such as community-led development and empowering local entrepreneurs.

The Organization has ambitious plans to scale the Symposium to an international conference. Although year by year themes will shift, it will maintain an ongoing focus on collaboration, and continue to be central to Posner Center's efforts to establish Denver and our Center as a leader, convener and facilitator for global development work.
